Pursuant to the requirements of N.J.A.C. 6A:30, the South Plainfield School District has undergone the Quality Single Accountability Continuum (QSAC) review. I am pleased to inform you that your district has satisfied at least 80% of the weighted indicators in each of the five areas of the QSAC review process and has been designated as "high performing." Commissioner Hespe will recommend to the State Board of Education that your district be certified as providing a thorough and efficient system of education, for a period of three years or until the next QSAC review. Congratulations on this accomplishment.
